After assessing such files in the Certification Evaluation Report (ref. CER/EVR/IDN/2021-001 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303:2015 and ISO/IEC 14443:2016 Specifications.
