After assessing such files in the Certification Evaluation Report (ref. CER/EVR/IDN/2021-008 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303: 2015 and ISO/IEC 14443: 2016 Specifications.
