In connection with your request, we have reviewed your Implementation Conformance Statement (ICS), referred to as IDN.THA.EMRTD.2022-001 dated 17/03/2022 and we have assessed your Test Reports (references: IC.E.RE.2203.003_v1.1 (Dimension/Analog), IC.E.RE.2203.004_v1.1 (Analog), IC.E.RE.2203.005_v1.1 (Digital), IC.E.RE.2203.006_v1.1 (Application)) generated by the laboratory ICUBE Testing Center, following the Test Plans "ISO 18745-2: Part 2", "ICAO TR- RF Protocol and Application test standard for eMRTD - PART 3" and "AFNOR/BSI TR-03105—Extended Access Control (EACv1)".

After assessing such files in the Certification Evaluation Report (ref. CER/EVR/IDN/2022-001 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303: 2015 and ISO/IEC 14443: 2016 Specifications.
