After assessing such files in the Certification Evaluation Report (ref. CER/EVR/IDE/2022-002 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303:2015 and ISO/IEC 14443: 2016 Specifications.
