In connection with your request, we have reviewed your Implementation Conformance Statement (ICS), referred to as IDN.IPZ.EMRTD.2024-002 dated 2024/02/08 and we have assessed your Test Reports (references: IC.E.RE.2309.027_v1.0 (Dimension/Analog), IC.E.RE.2309.028_v1.0 (Analog), IC.E.RE.2309.029_v1.0 (Digital), IC.E.RE.2309.030_v1.0 (Application)) generated by the laboratory ICUBE Testing Center, following the Test Plans "ISO 18745-2: Part 2", "ICAO TR- RF Protocol and Application test standard for eMRTD - PART 3" and "AFNOR/BSI TR-03105–Extended Access Control (EACv1)".

After assessing such files in the Certification Evaluation Report (ref. CER/EVR/IDN/2024-036 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303: 2021 and ISO/IEC 14443: 2016 Specifications.
