Dear Customer,

Calypso Networks Association, hereafter referred to as "CNA", has received a request, dated 4 December 2019, submitted by Watchdata Technologies, your company, hereafter referred to as the "Vendor", for the Certification of the Portable Object, hereafter referred to as the "Product", identified above.

Arguing that the modifications of the original product were minor, you have asked us for an extension of the certificate CNA-150527-CPOC-15 granted on 10 July 2015 to the product TimeCOS DI Calypso version 1.0.



After assessing the differences between the two products presented by the Vendor, CNA considers that the modifications have no reason to affect the behaviour of the Product with regard to the Calypso rev3 functionalities.
