The CNA granting of the certification to your Product is subject to the following terms and conditions as listed here after:

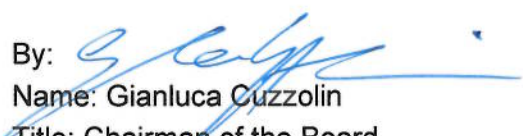
- i) The Vendor commits to the CNA certification procedures to obtain the Certification and therefore is valid from 11 January 2018 and will expire on 10 January 2028.
