In connection with your request, we have reviewed your Implementation Conformance Statement (ICS), referred to as IDN.IDE.EMRTD.2019-003 and we have assessed your Test Reports (references: KL.E.RE.1807.019\_v1.0, KL.E.RE.1807.023\_v1.0, KL.E.RE.1807.027\_v1.0, KL.E.RE.1807.031\_v1.0) generated by the laboratory ICUBE, following the Test Plans "ISO/IEC 18745-2: Part 2", "ICAO TR- RF Protocol and Application test standard for eMRTD - PART 3" and "AFNOR/BSI - Advanced security mechanisms for machine readable travel documents – Test plan for eMRTDs with Advanced Security Mechanisms – EAC 1".

After assessing such files in the Certification Evaluation Report (ref. CER\_EVR\_IDN\_2019-065 v1.0.0), the Certification Body has found reasonable evidence that the submitted samples of the above referenced Product sufficiently comply to the ICAO Doc 9303: 2015 and ISO/IEC 14443: 2016 Specifications.
